The mission of LifeBridge Partnership is empowering people with disabilities to develop skills for independence and to actively participate in the community. LifeBridge serves St. Louis City, St. Louis County and St. Charles County.

Out and About Program - "Out and About" program provides support services to individuals with disabilities. These support services enable clients to explore the St Louis area, develop skills for independence, or maintain skills needed to be active in community life. Support services are provided in small group, recreational settings and include accessible door-to-door transportation. In planning and participating in activities, individuals work with staff and peers to form and cultivate relationships, explore the community, conduct monetary transactions, interact with other community members and learn how to navigate community venues. As a result, the individuals gain knowledge, experience and resources needed to actively and independently participate in community life.

4b (Code:) (Expenses \$ 72,751 including grants of \$) (Revenue \$ 33,620)

Youth Recreation Program - The Youth Recreation program serves children with disabilities, ages 6 to 21. Program activities provide clients opportunities to explore the community, practice skills for independence and develop friendships. In addition to providing respite to families and caregivers, this program promotes inclusion. As needed, clients may utilize the agency's accessible, door-to-door transportation services.

4c (Code:) (Expenses \$ 167,095 including grants of \$) (Revenue \$ 125,993)

LifeBridge Camps - This program provides four, week-long day camps for youth with disabilities. Clients participate in activities such as sports, art and music therapy, and community field trips. Clients may also experience special presentations through partnerships with groups such as first responders, aviation professionals or animal trainers. Accessible transportation is provided from centralized meeting points or, as needed, clients may utilize the agency's accessible, door-to-door transportation services.
